### **Requirements prior to breeding:**

Prior to accepting your female, we must receive the following information unless other arrangements have been made and agreed to by both parties with an addendum to this contract:

- Photograph and 3 generation minimum pedigree
- AKC and/or UKC registration
- OFA Certification of Hips and Elbows
- Current CAER number or eye report from a certified ophthalmologist
- Up to date immunizations certificate (required for boarding)
- Negative Brucellosis test dated within 14 days of breeding
- EIC, CNM and PRA test results. Can be carrier, but not affected.
- Color DNA test showing no dilute color gene (D Locus). We do not knowingly breed dogs carrying the dilute color gene and will not approve a litter for registration if it is determined to have been whelped by a dilute carrying female. To protect yourself it is highly recommended that your female be DNA tested for the dilute gene prior to the breeding. The bitch owner agrees that no puppy from this breeding will be sold to a pet shop, agent, or broker.
- The stud owner is not obligated to sign an application for litter registration with the AKC or UKC, nor may such application be made, unless/until all applicable terms of this agreement have been complied with in full.
- The bitch owner agrees that no puppy from this breeding will be sold to a pet shop, agent, or broker.

<u>Progesterone Testing</u>: A Progesterone test is a blood test to determine the optimum time to breed your female. Progesterone testing not only pinpoints the time to breed but it also helps to ensure maximum litter size. Usually two or three tests are needed before reaching the optimum time to breed. We require progesterone testing if the female's owner utilizes fresh chilled or frozen semen for their breeding.

#### **Stud Fee:**

The stud service fee

- a. is \$1,500.00 (U.S.), or 1<sup>st</sup> Pick Puppy. to be paid as follows:
  - A <u>non-refundable</u> breeding fee of \$500.00 will be due prior to breeding along with the signed stud
  - Should the pregnancy result in 3 or fewer puppies, there shall be no additional fee.
  - The Female's owner will pay an additional fee of \$1,000.00 within 2 weeks of whelping should the pregnancy result in 4 or more viable puppies.
  - If all fees are not paid, the stud dog owner will not approve the litter registration

<u>Puppy in Lieu of Fee Clause:</u> Stud Dog Owner(s) reserves the right to take a puppy in lieu of a stud fee, unless stud fee is paid in full up front prior to breeding. Stud Dog Owner(s) will choose said puppy at 7 weeks of age, before any puppies from said litter have left the bitch owner's residence, after examination of litter by Stud Dog Owner(s) or his/her representative. The puppy will carry the Stud Owner's kennel name as a prefix.

Natural or Fresh AI— The non-refundable breeding fee of \$500.00 is due prior to first breeding. During the times when Boogie is available for a Natural or Fresh Semen AI breeding, we feel that it is best to always have a back-up plan. We realize it is a big expense to ship or even drive your female to Kentucky and we don't want the trip to end in failure. Therefore, if you opt for a natural breeding and your female is non-receptive or for any reason a natural tie is unsuccessful, the owner has the option for a Fresh Semen AI. All fees associated with a Fresh Semen AI are payable to veterinarian performing the collection and AI at the time services are rendered and are the responsibility of the female's owner.

Fresh Chilled Semen AI - (Shipped Only) - The non-refundable breeding fee of \$500.00 is due in full prior to the release
and shipment of fresh chilled semen unless other arrangements are made in advance. The female's owner is responsible for
all fees associated with the collection, preparation and shipment of fresh chilled semen. These fees are separate from the
stud fee and is payable to the storage and shipping facilities directly. If conception fails, we offer one repeat breeding for
the same female on her next heat. All fees associated with the repeat breeding are the responsibility of the female owner.
To qualify for the repeat breeding, the female must have had progesterone testing and bred on the optimum date.

**Frozen AI** – The non-refundable breeding fee of \$500.00 is due in full prior to the release and shipment of frozen semen unless other arrangements are made in advance. Frozen Semen AI is a surgical procedure. Arrangements must be made in advance if you are planning surgical implantation. All expenses associated with the shipment of frozen semen and the return of the container is the responsibility of the female's owner. These expenses are paid to the storage facility. It is the female owner's responsibility to contact the storage facility and to coordinate shipping arrangements to your veterinarian.
